CONTINUATION SITE VISIT NOTES

- from appearance of the building it was my opinion that building was older than four (4)
 years (confirmed by Mr & Mrs Blanchard)
- prior to visit planning history of swelling shows no history of kennels being authorised,
 although perhaps unlawful, no enforcement action can be taken due to four (4) year rule.
- There is no evidence to show that kennels have been recently extended as there is no evidence what was previously in place. Mr & Mrs Blanchard states building not extended again confirm nine (9) years.
- Mr & Mrs Blanchard allowed me full access to the grounds. I saw no evidence of cruelty to any animal, if seen then I would have no hesitation in reporting such.
- Mrs Blanchard showed me documents. She presently has 27 dogs (which includes two (2) wolfhounds). GBGB steward, Colin Betteridge last visited in April 2009 to look at some of the dogs. Apparently since kennel hand left they have had visits from RSPCA and GBGB.
- The conditions for keeping of and housing of the dogs are not a planning issue and I can only assess 2nd kennel block.
- NFA no planning history building appears older than four (4) no enforcement action due to four (4) year rule.
